Athletic Waiver & Release of Responsibility

In consideration of being permitted to use the Pettit National Ice Center and represent the Wisconsin Figure Skating Club, the undersigned participant, and the parent or legal guardian if the participant is a minor, (hereinafter "Releasor(s)):

1. Agree to inspect Pettit National Ice Center facilities and any equipment to be used prior to use or participation. If the facility or equipment is found to be unsafe by the Releasor(s), the Releasor(s) shall immediately notify the Wisconsin Figure Skating Club of the unsafe condition and refuse to use the unsafe facility or equipment. If any athletics/sports program or activity is found to be unsafe by the Releasor(s) to provide all personal equipment and protective devices and to maintain such equipment and items in proper condition.
2. Acknowledge and fully understand that the athletics/sports programs or activities to be engaged in involve risk of serious injury, including disability or death, and severe social and economic losses that may result not only from their actions, inactions or negligence, but also the action, inaction or negligence of others, the rules of play, or the conditions of the facilities or of any equipment used. Further there may be other risks not known to or reasonably foreseeable at the time of use or participation.
3. Knowing of the foregoing risks, Releasor(s) agree to assume those risks and accept personal responsibility for all damages following such injury, permanent disability or death.
4. Release, waive, discharge, and covenant not to sue Pettit National Ice Center, Wisconsin Figure Skating Club, its affiliated clubs, their administrators, directors, coaches, or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, the owners or lessees of premises used to conduct the program or activity, (all of which are hereinafter referred to as "Releasees"), from any and all liability to the Releasor(s), their heirs or assigns for any and all claims, property damage, caused or alleged to be caused in whole or in part by the negligence of the releasors.
5. The WFSC may photograph or record rehearsals or performances of Red White & Blades for the purpose of documentation or promotion. Red White & Blades performers hereby release the WFSC to use those images for future WFSC communications.
