**Show Number Eligibility Maximums:** Eligible skaters may register up to the number of show numbers, based on the highest Moves in the field (MIF) OR Freestyle (FS) test passed, whichever is applicable. See Show Number Order Form for details (page 3). Note: The show organizers cannot guarantee the skater's requested show number registrations. Skaters will receive a refund for the show number(s) we cannot fulfill. No refunds will be given for a skater's withdrawal from a show number after close of registration.

**Shows and skater cast selections.** Look for email message posting on our website, the week of March 15, 2010.

**Show Communication, schedules and excused absences.** Please see the attached *Tentative Show Practice Calendar* (check the website calendar and emails for the most up-to-date schedules). Emails, website and rink-side postings will be the primary ways to communicate show information to skaters, parents and volunteers. *If you do not have internet access or email, please ask your skater to check rink-side postings for any updates when rehearsals begin in April. Skaters are responsible for requesting excused absences from show professionals.*

**Costumes:** Skaters need to wear a black sleeveless tank leotard (may be provided; volunteer coordinator will confirm at later date) and tan **over-the-boot** skating tights to the dress rehearsal and all shows (coaches may change this at later date; volunteer coordinator will confirm). An additional costume fee or purchase may be required and announced at a later date.

In such cases, the registrant will contact you for your approval and payment of \$30 for this additional number. If accepted, an addition 5 hours of volunteer time would be required. Guest skaters must meet qualification guidelines.

**Synchro Team Exhibition:** The team exhibition fee of \$30 is waived for registrants participating in a show number in addition to their Team Exhibition, i.e. 1 number + Team Exhibition would be \$85.

\*\*Registrants only participating in their Team Exhibition would require a \$30 fee (Subject to increase in future years, based on true show production costs, pro-rated for each team skater). This includes one show performance per team, details to be determined by the show coaches. Also includes a show t-shirt and dress rehearsal pizza (May 13, 2010). Parents are also required to contribute 3 volunteer hours for the show.

\*\*\*Registrant fees participating in an Adult Synchro Team number will not include t-shirt or dress rehearsal dinner.

### Skater Waiver and Red White & Blades 2010 Participation Agreement

As a Red White & Blade participant I/my child will:

  - I will abide by the stated conduct and attendance guidelines set forth in the registration packet and take personal responsibility to communicate with the show professionals, and show organizers if I cannot fulfill my responsibilities.
  - Be prepared at each performance with the necessary costumes, hair style and make-up.
  - Keep my locker room clean during show performances
  - I will skate my best during each rehearsal and performance so the audience will truly enjoy their experience at Red White & Blades.

**I/parent or guardian (if under age 18 years), in addition to signing this agreement below, agree to sign the WFSC's "Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, RWB2010 Attachment A.**

As Parents/Guardian (skater under 18):

- I/we will encourage sportsmanship by showing positive support for all members, ice show skaters, coaches, Board members and other officials during all on and off ice sessions.
- I/we will encourage our child to treat all others with respect.
- I/we will also refrain from coaching my child or "manipulating" other members during any on and off ice sessions; will not verbally or physically abuse any club members, volunteers and will represent myself positively and not undermine the authority of coaches, club Board members, officials, or other club volunteers.
